DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

1830 & 1875

A c. 1830 one-room, one-story building now serves as the rear kitchen for the c. 1875, two-story farmhouse. Both structures are built in frame with wood-shingled gable roofs. The long three-bay facade of the main house faces the Patuxent River $\frac{1}{4}$ mile to the east.

The main house features a center hall with a parlor to either side. Each parlor is heated by an interior end brick chimney.

The two-bay-wide kitchen's south door is protected by a shed-roofed hood supported by brackets. A tiny window lights the east end alongside the interior brick chimney. The other windows may have been six over six.

The kitchen has a timber frame covered with random width weatherboards. The balloon frame of the main house is covered with German siding. The barge boards are cut in decorative waves. Both sections stand on piers of various materials.




