DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Two three-bay-long one-story sections compose this stuccoed frame house. The western section has a side-hall single parlor plan. Although the two sections share a common gable roof line, two gabled dormers light the western part, while two shed-roofed dormers light the eastern part.

An interior brick chimney heats the west end. An exterior concrete-block stove-flue chimney has been added to the east end. The west section features a central entrance. The west section's entrance is in the easternmost bay, while the east section features a central entrance. The west gable end includes a door at the north end and a six over six attic window to the south. Six over six sash also light the gabled dormers. Two over two sash light the two western windows. One over one sash windows appear in the eastern section.

A three-pane transom tops the side-hall's entrance. The stair begins along the east wall of this section, then crosses a full landing before returning. Thus the stair hall occupies a disproportionate third section of the house.

The house stands on a brick foundation. Patterned sheet-metal covers the roof.

A frame tobacco barn stands c. 1000 yards down a lane to the north. It may be contemporary with the dwelling. Sheds cover the south and east sides. Horizontal siding sheathes the south gable end. Wood shingles cover the roof.

STATEMENT OF SIGNIFICANCE

This house and barn are fairly typical for a moderately successful mid-19th century farm in Calvert County. The full-sized stair hall is awkward in a one-story building height, as is seen when one arrives at the landing, where there is little head room under the eaves. Despite this difficulty, a surprising number of just such buildings were built in the county, including the original sections of CT-504 St. Leonard's Shores House and CT-216 Soper House, both of which were later raised to a more comfortable full two stories.
