DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame house measures three bays wide by one bay deep. A prominent cross-gable distinguishes the facade. The gable-roofed house includes a front porch and a rear kitchen. 2/2 sash windows light the dwelling.

The south facade's eastern entrance includes sidelights and a transom. This side's porch features chanifered posts, decorative brackets, and a plain balustrade relieved by blocky turned posts at its western opening.

The cross-gable is unfenestrated. Interior brick stove-flue chimneys heat the main block's west gable end, and the two-story two-bay kitchen's center. A one-story addition crosses the kitchen's west side. Regularly-spaced wooden shingles sheathe the walls.


