This turn-of-the-century house faces west onto Old Town Road. It is a two-story framed and weatherboarded L-plan house with a gable roof covered with decoratively molded sheet metal. There is a brick chimney set at the juncture of the two crossed gables. The entrance to the house is in the one-bay north side wing. A single-story hipped-roof porch set on turned posts with pierced and sawn brackets follows the west and north faces of the forward-facing wing. The rear extension of the building has a one-story hipped-roof kitchen addition. The one-over-one sash are added, and the house has recently been sheathed with vinyl siding.

Sidelights and a transom light the northern entrance on the west facade. Two over two sash windows framed in plain flat boards light the house. An interior brick stove-flue chimney heats the center of the dwelling. Turned posts and decorative brackets highlight the porch. Plain lapped weatherboards cover the house.






