Interior brick stove-flue chimneys heat the main section's east gable end and the two-story kitchen ell's south gable end. The north facade's cross-gable is unfenestrated. This side's porch retains scrollwork brackets. Modern finishes cover the dwelling.

Several frame farm buildings complete the complex.


