This two-story frame house measures three bays wide by one bay deep. A prominent cross-gable distinguishes the facade. The gable-roofed house includes a front porch and a rear kitchen section.

A central bay containing a central entrance projects under the cross-gable on the east facade. Each bay contains paired six over six sash windows framed in plain flat boards. A single brick stove-flue chimney appears north of center.

A modern barn completes the farm.
