This turn-of-the-century house is located on a hilltop, facing southwest toward Maryland Route 765. It is a two-story T-plan, but the front-facing stem of the T is smaller with more narrow proportions than usual and the first-story corners of the T stem are clipped. It looks more like a bay appendage to the main house than part of the original design. The house is framed and weatherboarded, but aluminum siding has been added. The gable roof is covered with corrugated sheet metal. The windows have two-over-two double-hung sash. There is a one-story screened-in porch with a front-facing gable roof. One-story shed additions have been made to the side and rear.


