This house is located at the southeast corner of Maryland Route 765 and Armory Road. Set well back from both roads, the house faces south. It is a two-story T-plan with an extraordinarily long front-facing gable. Furthermore, the angle between the stem and the bar of the T is filled in. The entrance to the house is in this funny section, which may be an addition to the original house. The structure is set on a brick foundation, is framed and weatherboarded, with two-over-two double-hung sash. The gable roof is covered with asphalt shingles. There is a central brick chimney. There are no additions and no surviving porches.


