This house faces south onto Armory Road. It is a turn-of-the-century two-story single-pile, three-bay, side-passage-parlor-plan house. The gable roof is covered with standing-seam sheet metal. The one-story hipped porch is supported by chamfered posts. The windows are glazed with two-over-two double-hung sash. A broad front-facing gable is centered over the central bay. There is an interior gable-end chimney. There is a rear two-story ell and one-story additions.

A hip-roofed porch covers the first-floor elevation. The right-hand door and left-end chimney suggest a side-hall, single-parlor plan.


