Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

The Stanley L. Watson Cross-Gable was previously surveyed in 1980 and 1986. A determination of eligibility was not provided during either survey of the property. This previously surveyed resource is a farm complex consisting of a residence fronting Fairground Road and several wood-frame outbuildings. Since the prior survey, the original 2/2 double-hung wood windows have been replaced with 1/1 vinyl units. The surrounding agricultural land is uncultivated and reforesting.

Webster Tabbs accumulated several parcels totaling 114 acres during the late nineteenth century. This tract of land was sold to James Rawlings in 1904. Based upon architectural evidence, the house was constructed on the property circa 1905. The Rawlings family lost the property during an Equity Court ruling in 1956, at which time, Stanley L. and Nora B. Watson became the owners of the house and 113 acres. Nora Watson is the current owner, though the property now contains only 7.5 acres.

The property is recommended as not eligible for the National Register of Historic Places. This turn-of-the-century vernacular house is a common building type for the region. Better examples exist that possess greater material and architectural integrity. In addition, the deteriorated outbuildings and uncultivated reforested fields do not convey the former agricultural use of the property. The property does not represent an historic event or trend that made a significant contribution to the development of the nation, state, or local community, and therefore is not eligible under Criterion A. cursory historic research indicates that


the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. It is not eligible under Criterion C as it is an indistinctive example of a common building type. The integrity of the structure has been compromised by window replacements and siding material alteration. Investigations have not been conducted to determine whether the property has the potential to yield information important in history or pre-history, therefore, National Register Criterion D can not be assessed at this time.

This turn-of-the-century three-bay I-house faces west onto Fairgrounds Road. It is set onto a concrete-block foundation. It is wood framed and was originally sheathed with weatherboards. Asbestos shingles are the present siding. There is one exterior brick chimney on the south gable end wall and an interior brick chimney on the north gable end. The sash are two-over-two double-hung. The gable roof is covered with decoratively molded sheet metal. The two-story brick ell has an exterior brick chimney on the gable end. The facade of the house is sheltered by a one-story porch with turned posts embellished with sawn and pierced brackets. The porch has a paneled cornice.

Located behind the house are five framed vertical-boarded barns and one framed and vertical-boarded granary, all with standing-seam sheet metal roof coverings.


