This small farm sits on a flat plain at the edge of the Patuxent River. It comprises a two-story frame cross-gable farmhouse, a one-story garage and tool shed, and a tiny gambrel-roofed barn.

A two-story, two-bay by one-bay kitchen runs to the rear of the house. A stove flue heats its gable end. A shed-roofed one-story addition covers the kitchen's east side.

The cross-gable's main facade faces south. A stove flue heats either gable end. The gables are not fenestrated. One window appears on either floor at the east end of the east gable. The three-bay facade features a center door. A shed-roofed porch runs across this side.

All windows in the house are shuttered.
