Late 19th Century

This is an especially stately example of the two-story cross-gable frame farmhouse. The east-facing facade includes a central entrance in its five bays. Two chimneys located on either side of the central hall heat the parlors. A porch runs across the entire first floor. Louvered shutters flank the 2/2 sash windows. A rectangular louvered vent appears in the cross-gable as well as in the main gables.

A two-story kitchen forms an "L" to the west. A partially-enclosed porch fills the "L"'s southwest corner.


