DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is on the west side of Barstow Road, within sight of the main house at Willow Glen. Beatrice Smith has worked at Willow Glen for "50 years or more" and has occupied this house since 1941. She says that the "oldest part is from slave times", and that both white and black families have lived there.

The two story, north wing has been built since 1941, but the south wing is obviously much older. It is, in fact, a log cabin made of squared logs laid horizontally and joined with V-notches. Vertical boards with battens cover the outside being attached with cut-nails. The eaves are boxed-in and the gables are covered with clapboards. Fieldstone chinking inbetween the logs and thick hair-plaster on the interior provide added insulation. The cabin measures 15' x 17' on the exterior, and the distance between the sills and plates is 11". The sills rest on large ironstone piers, which are c. 2' high in the front (East.)

The plan of the cabin itself is one up/one down. The walls extend above the ceiling joists approximately 1 1/2' constituting a "half story" which is somewhat cramped due to the pitch of the gable-end roof. There is a frame kitchen addition in the rear (West), which is later than the log portion (whitewashed clapboards are visible on its inside east wall), but older than the north wing. The exterior of the kitchen is covered with clapboards. The north wing is also one up/one down but is a full two stories. It provides a parlor and a second bedroom.

The interior of the cabin exhibits exposed hewn ceiling joists, an enclosed stairs in the northeast corner, and there appears to have been a hearth in the middle of the south wall. A large 6/6 window replaces it; but on the interior, one can observe an interruption in the floor that is a depression the size of a hearth. Modern floor covering made further examination impossible.

Access was not gained to the upper story.




