Early 20th Century

Two three-bay-long sections set at right angles form this two-story frame farmhouse. The east section's gable roof runs north-south. A stove flue heats the north end. The north-facing west section is lighted by two 6/6 sash windows on either floor. The central door is attached to the east window.

This house appears to have been abandoned for a number of years. Its asphalt shingles are falling off, revealing plain lapped weatherboards underneath.


