This house is a two-story, three bay frame dwelling of the late Queen Anne style. It is distinguished by a central cross gable and by a semi-hexagonal projecting bay at the southeast corner. Windows have single pane sashes and are trimmed with broad, flat architraves. The main entrance is located in the center bay of the front elevation.

Hipped roof porches extend along the front and sides of the house. The main roof of the house is also hipped except for the cross gable. A brick chimney extends from inside the east wall.

This house combines the earlier cross gable feature so prevalent in Calvert County with the popular two-story bay window and the later pyramid-roofed square house form. Further research is needed to establish the historical significance of this house.



