## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame farmhouse faces south. It includes a kitchen ell to the rear. A central cross-gable and central entrance lend symmetry to the three bay facade. A hip-roofed porch covers this side.

Two over two windows framed in plain flat boards light the house. Tiny two over two windows light either gable end as well as the cross-gable.

An interior brick stove-flue chimney heats either gable end. Standing seam metal covers the roof. Lapped weatherboards sheath the walls.

Several frame sheds stand north of the house.




