Huntingtown Hall is located at 4290 Hunting Creek Road in Huntingtown, Calvert County, Maryland. Also known as the American Legion Hall, Calvert Post No. 85, Huntingtown Hall was constructed circa 1914 by the Huntingtown Improvement Company. According to the Articles of Incorporation of the Huntingtown Improvement Company, the hall was constructed for the purpose of providing the people of Huntingtown with a place to better themselves through education and art appreciation. For a short time in the 1940s, Huntingtown Hall was used a school. Between 1945 and 1957, the hall was owned by the United Methodist Church of Huntingtown. Following the church's ownership, the building became the home of Calvert Post No. 85 of the American Legion and has served in that capacity since. Additionally, the hall provides space for a dance studio for Calvert County youths. The American Legion Hall, Huntingtown Hall is a rare survivor of the local community halls that were built throughout Calvert County during the late-19th and early-20th centuries.

Huntingtown Hall is a one-story, wood-frame building with a steeply pitched front-gable roof. The building, constructed circa 1914, is clad in vinyl siding and features 1/1 vinyl sash windows, hollow metal exterior doors, and a corrugated metal roof. The interior brick chimney with a corbeled cap rises from the apex of the roof at the north end of the main block. The hall has been enlarged by two additions, both with parapeted shed roofs. One addition runs the entire length of the east elevation and the other stands to the rear of the main block. The interior of the hall retains the single open-room plan, although the raised stage at the north end has been removed. A modern, one-story shed with a gambrel roof is located to the northeast of the building.

Huntingtown Hall is located at 4290 Hunting Creek Road in Huntingtown, Calvert County, Maryland. Also known as the American Legion Hall, Calvert Post No. 85, Huntingtown Hall is a one-story, wood-frame building with a steeply pitched front-gable roof. The building, constructed circa 1914, is clad in vinyl siding and features 1/1 vinyl sash windows, hollow metal exterior doors, and a corrugated metal roof. The interior brick chimney with a corbeled cap rises from the apex of the roof at the north end of the main block. The hall has been enlarged by two additions, both with parapeted shed roofs. One addition runs the entire length of the east elevation and the other stands to the rear of the main block. The interior of the hall retains the single open-room plan, although the raised stage at the north end has been removed. A modern, one-story shed with a gambrel roof is located to the northeast of the building.

EXTERIOR ELEVATION

The primary, street-front elevation of the American Legion Hall, Calvert Post No. 85 is on the south. This elevation is characterized by the two-part façade consisting of the gable end of the original hall and the front of the circa 1961 concrete block addition. The original portion of the hall is largely unornamented, with a single pedestrian door in the center flanked by two windows. The addition features a door on the west side and a wide aluminum picture window on the east side with a brick rowlock sill and false shutters. Both doors on this elevation are sheltered by a metal awning.

The east elevation is dominated by the one-story addition that extends the entire depth of the original hall. Towards the back of the addition is a door covered by a metal awning, and on each side of the door are horizontal-sash windows with false shutters. This elevation also exhibits the east side of the rear addition that features a stepped parapet.

The rear, or north, elevation of the hall exhibits one horizontal-sash window in the concrete block addition to the east, and two small windows high on the addition that projects from the rear of the original hall. This addition appears to have partially obscured a window opening or door on the back of the original hall. A new door is present in the back of the hall, accessed by a wood stair.

The west elevation shows the original hall and the concrete addition to be flush on this side. Fenestration is confined to the hall, which exhibits five irregularly spaced window openings, four of which are flanked by false shutters.

INTERIOR DESCRIPTION

The interior of Huntingtown Hall reflects its original configuration. The original portion of the building is still one single room, although a partition separates a small vestibule area inside the front door. The addition to the east is composed of two primary spaces, the meeting room to the south and the kitchen to the north, with bathrooms, a storage area, and hall between them.

The building has been extensively renovated on the interior and now exhibits compressed particleboard simulated-wood paneling on the walls and synthetic acoustical tile on the ceilings, which have been dropped to hide the electrical work. The original hall now features hard wood strips on the floor that appears to be modern. The east addition features carpeted floors. It is interesting to note that throughout the east addition are what appear to be reused original doors with five horizontal panels and ceramic knobs.

NON-HISTORIC RESOURCES

In the northeast corner of the lot containing Huntingtown Hall is a modern one-story shed with a gambrel roof.

THE COMMUNITY HALL IN CALVERT COUNTY

Historically, one of the most significant public meeting places in Calvert County was the community hall, extant examples of which date primarily to the late 19th and early 20th centuries. Community halls, located in villages and small towns rather than in heavily rural locations, were built for the expressed purpose of serving as a public meeting location for the surrounding community and in many ways were as a substitute for the town halls of larger, more populated towns such as North Beach and Prince Frederick. These buildings were generally one-story wood-frame, gable-roof buildings with one large room on the interior with a raised stage at one end. The hall would be utilized by local organizations and residents for meetings, social events such as dances and parties, theatrical productions, political rallies, lectures or other occasions. To some extent, these functions would have been shared by church parish and social halls, as in the case of St. John's Methodist Church Hall on Sollers Wharf Road or The Grange Hall on Broomes Island Road, affiliated with Christ Church, both now demolished. Waters Ross of Mutual Farm in Broomes Island remembers attending dances at The Grange Hall as a young man in the 1930s, while Agnes Jefferson recalls taking her young children to St. John's Methodist Church Hall to be inoculated during the 1950s. (1) Very few of these community halls remain in Calvert County.

HISTORY OF HUNTINGTOWN HALL

Huntingtown Hall, now the American Legion Hall, Calvert Post No. 85, was built following the incorporation of the Huntingtown Improvement Corporation in 1914, which declared as its mission the "creation and maintenance of a Public Hall for Library, Lectures, Theatricals and other lawful amusements in the village of Huntingtown." (2) As built, the new community hall appears to have been a one-story, wood-frame, gable-roof structure with 2/2 windows, clad in lapped wood siding and consisting of one large open room on the interior with a raised stage at the south end, much like Mutual Hall in Mutual, Calvert County, Maryland. (3) In 1942, Huntingtown Hall was used as a school when the Huntingtown School burned down. The school was not rebuilt until 1945,

and classes were taught at the hall for the duration of that time. It was during that time period that the one-story addition on the east elevation was constructed by Calvert County as a lunchroom for the students.

In 1945, Huntingtown Hall was sold to the Huntingtown Methodist Church. During the Church's ownership, the hall was used for dinners and plays were held on the raised stage. Local residents also recall dances and boxing matches being held in the hall. As with other community church buildings, the local residents continued to use the building for meetings and social events during this period. Among other groups that met there was the Calvert Post of the American Legion. (4) Twelve years later in 1957, the building was purchased by the American Legion, Calvert Post No. 85.

The American Legion was chartered in 1919 by an act of Congress as a patriotic, mutual-help, wartime veterans' organization. (5) The organization proclaims as its mission the defense of the United States Constitution, the promotion of law, order and "Americanism," and the remembrance of the events and associations of the major wars, and has traditionally been a strong supporter of the Boy Scouts of America and other charitable organizations for children. (6) During the 1950s, nationwide membership in the American Legion had reached an all time high of over three million U. S. Armed Services veterans of both World Wars and the Korean War, a large percentage of which were from rural and small town areas such as Calvert County. (7) Calvert County hosted a number of posts including those in Chesapeake Beach, Huntingtown and Prince Frederick. As with many other organizations of this type, the American Legion had a counterpart women's group called the American Legion Auxiliary, which held their own meetings and participated in their own events and charities. As suggested by the deed from the United Methodist Church, the American Legion posts in Calvert County, and in other places across the country, were racially segregated. Because membership in many American Legion posts was closed to African Americans, African Americans formed their own posts, as in the case of the American Legion Gray-Ray Post 220 (CT-1290) in Prince Frederick.

The Calvert Post of the American Legion was chartered on April 29, 1920. (8) Before the purchase of Huntingtown Hall, the Calvert Post No. 85 had been meeting at various locations in Calvert County, including the county library and for an extended period in Allen Bowen's garage. (9) Several restrictions were placed on the building when it was sold to the Calvert Post No. 85, including the prohibition of the sale or manufacture of any "intoxicating liquors" on the property, and the sale or occupancy of the building by "any person of the negro race." (10) Restrictions of this kind were common in the sale of lodge and church buildings during the period. In the 1980s, a new deed was drawn up, in which the restriction was altered to state that no alcohol could be sold, rather than no alcohol served.

The American Legion made several renovations to the hall following its formal dedication in 1961, including the addition of modern bathrooms, air conditioning and central heating. (11) The Calvert Post No. 85 again made renovations to the building circa 1991, including the application of vinyl siding. (12) The building continues to serve as the post home of the American Legion Calvert Post No. 85, which holds its meetings in the 1957 addition, although the original portion of the building has been renovated and is now used by the Calvert School of Dance.






HUNTING CREEK ROAD (RTE 521)



This lodge hall is set right up on the road, oriented with its gable end facing south. It is supported by a low concrete-block foundation and is framed with weatherboard siding, the narrow, 1920's kind. The rafters have sawn curved ends left exposed. The roof is covered with sheet metal. A brick stove flue is situated near the rear end wall. The side walls are five narrow bays long. The windows are glazed with one-over-one double-hung sash. The three-bay front of the building has a central doorway that has recently been reduced in size. There is a rear concrete-block addition and a stuccoed recessed east wing, both dating to the 1950's or 1960's. The main structure appears to date from the 1920's.




