This house is associated with the contractor's office next door, but it was built several decades later, around 1930. It faces east onto Old Town Road. It is a big one-and-a-half-story, framed and weatherboarded house with a three-bay facade composed of two one-over-one windows and an entrance with sidelights. The placement of the door at the northeast end of the house indicates a side-passage plan. The gable roof is covered with decoratively molded sheet metal. There is a brick chimney located in the center of the building and on the front plane of the roof. This is one of those bungalow-inspired houses that is actually two full stories high, (and looks like two full stories on the gable-end walls) but the upper story is illuminated by a broad three-bay shed dormer on the front of this house, giving it the appearance of a cottage-like, story-and-a-half dwelling. On the front of the house, the gable roof kicks out to become a shed roof for the front porch. The porch is supported by pairs of square tapering piers. There is a one-story shed-roofed rear extension, and a gable-roofed one-story projection on the south gable end. Both of these may be part of the original period of construction, or they are early additions.




