Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This building is still under construction. It faces east onto Highway 2/4. It is a low one-story polygonal building faced with white brick. It is illuminated by rows of three and four fixed-pane triangular-topped (pointed-arch) windows. At the corners of each polygon are advanced piers. These, with an advanced band around the cornice line, give the building a skeletal appearance. There is an east-facing three-bay arcaded entrance with lancet openings. On top of the structure is a smooth stuccoed plinth decorated with pointed corbels. On top of the plinth is a Moorish ogee dome which is lighted by clerestory pointed-arch windows. At the northeast corner of the building is a square-plan tower with a balcony decorated with pierced battlements. The lantern of the tower is topped by another ogee dome.




