This house faces south onto Armory Road. It is a two-story three-bay framed and weatherboarded structure with its gable end oriented toward the street. The sides are two bays long. The first-floor fenestration is three-bay, with a central door. The second story facade has only two bays. The windows have six-over-one double-hung sash. The gable roof is covered with standing-seam sheet metal. The foundation is made of concrete blocks. There is a brick stove flue in the west plain of the roof. The front porch is sheltered by an enclosed, hipped porch. There is a rear one-story shed-roofed addition.
