This house faces west onto Armory Road near the intersection with Fairgrounds Road. It is a bungalow, built sometime during the 1920's or 1930's. Set on a concrete-block foundation, it is a framed and weatherboarded structure with a rectangular form that is three bays wide and two rooms deep. The facade has a central entrance. The upper story is lit only by gable-end windows. The gable roof is covered with asphalt shingles. There is an interior brick chimney. The windows have single-pane sash. The porch is screened in, with a front-facing gable roof. The original weatherboards have been replaced with asbestos shingles.
