This two-story flat-roofed concrete-block commercial building faces west toward the intersection of Maryland Route 765 and 4th Street. The facade has a pressed and textured brick veneer embellished with vertical and horizontal panels of three stretcher bricks. There is a classical wooden cornice over the broad commercial window and the side doorway. Fluted pilasters also flank the doorway. The second story is illuminated on the facade with a pair of six-over-six, double-hung-sash windows. The building was probably constructed in the 1950's.
