This one-story commercial structure faces west toward the intersection of Maryland Route 765 and 4th Street. It is a framed structure, sheathed on the sides and rear with asbestos shingles. The front of the building has a brick veneer and a parapet roof. There are slightly advanced brick piers at the corners of the building. The structure enclosed two commercial units, each with polygonal plate-glass commercial windows and slightly recessed entrances. The building probably dates from the 1930's.
