This turn-of-the-century dwelling faces east, toward Maryland Route 765. It has been heavily altered to accommodate modern commercial uses. Set on a concrete-block foundation, the one-story framed T-plan house was originally covered with weatherboards. Asbestos shingles are the present sheathing. There are interior brick stove flues. The early and original windows have two-over-two and six-over-one double-hung sash. The facade has been completely removed, and the front of the house has been pushed forward to the facade of a modern flat-roofed enclosed porch area which has been fitted with wide commercial windows. A rear two-room ell is original to the structure. A shed addition has been built into the angle of the two sections of the T.
