This late nineteenth- or early twentieth-century dwelling faces southwest onto Maryland 765. It is a two-story rectangular-plan double-pile house set on a foundation of concrete blocks that are molded to look like ashlar. It is a framed and weather-boarded, gable-roofed structure that has recently been sheathed with vinyl siding. There are two interior ridgeline chimneys. The four-bay double-door facade includes windows with six-over-one double-hung sash, though some of the windows have been recently altered. A one-story hipped-roof porch is supported by wooden piers. The plan of the building has been heavily changed in the process of making the dwelling over into two sets of law offices.
