This side-gable bungalow faces west onto Maryland Route 765. Set on a concrete-block foundation, this dwelling is a one-and-a-half-story framed and weatherboarded structure with a central brick chimney. The two-bay facade is composed of a side door and a bank of three windows. The gable roof is interrupted by a three-bay gabled dormer. All windows have six-over-one double-hung sash. The gable roof extends forward to shelter the facade. This front porch is supported by square piers connected by rails and balusters. There is a one-story advanced bay on the south gable end -- it probably indicates the location of the original dining room. The original siding has been replaced by asbestos shingles.


