This 1920s Colonial Revival house faces west onto Solomons Island Road. It is set on a foundation of concrete blocks that are molded to look like rough -faced ashlar. It is a three-bay two-story double-pile framed and weatherboarded house with a gable roof and an exterior brick chimney on the south gable end. The central side-lighted entrance is flanked on the facade by three-part windows. The sash are six over six and double hung. There is a one-story flat-roofed balustraded screened-in porch built onto the south side of the house. The main entrance is sheltered by an arched and gable-roofed porch set on Doric columns.
