It is a wood-framed structure and covered with asphalt siding. The three-bay facade includes an off-center doorway and two-flanking windows. The windows are glazed with one-over-one double-hung sash. There is an off-center interior ridgeline brick stove flue and a one-story one-bay rear ell.


