This house, originally built in the late nineteenth century, faces west onto Solomons Island Road. It is a two-story three-bay framed and weatherboarded single-pile house with a side-passage-parlor plan and a gable roof. There is an exterior gable-end stove flue on the south side of the house. The windows have two-over-two double-hung sash. There is a two-bay-long two-story rear ell. The most arresting feature of the house is a recent addition: an advanced bay window set into the second story of the facade. A front-facing gable centered over the facade is illuminated by a triangular-topped window. Vinyl siding and new detailing, such as doors and window blinds, are all recent additions.


