This substantial early twentieth-century side-gable bungalow faces west onto Solomons Island Road. The walls are constructed of concrete blocks that have been molded to look like rough-faced ashlar. The gable ends, dormer, and south wing are all framed and weatherboarded. The two-bay facade is composed of a sidelighted and transomed doorway and a bank of three windows. The gable roof is interrupted by a front-facing gable-roofed three-bay dormer. The front face of the gable roof extends down and forward to become the front shed-roofed porch supported on plastered square-in-plan piers. There is a decoratively molded concrete fence at the perimeter of the lot.


