This mid-twentieth-century framed and weatherboarded bungalow faces west onto Sedwick. Like CT-903, it is set on a concrete-block foundation and oriented with its gable end toward the street. It is two bays long and has a three-bay facade. There is a concrete-block stove flue on the north side of the house. It has a screened-in front hipped-roof porch and a one-bay gable-roofed wing added to the south side. The original siding has been replaced.


