This one-story gable-fronted bungalow faces west onto Calvert Street. It is a framed and weatherboarded structure, two bays long, set on a concrete-block foundation. There is a concrete-block stove flue on the north side of the house. The siding and most of the architectural details have been altered. The facade is hidden behind a hipped-roof enclosed porch. Like the other nearly identical houses in this neighborhood, this structure dates from the middle of the twentieth century.


