This two-story single-pile framed and weatherboarded three-bay house faces west onto Solomons Island Road. It has a side-passage-parlor plan. There is an exterior brick gable-end stove flue. The house is extended by a two-story one-bay rear ell. The facade is sheltered by a one-story hipped-roof screened-in porch. The windows have two-over-two double-hung sash. This structure dates from the turn of the century. Its original weatherboarding has been replaced with asbestos shingles.


