This turn-of-the-century two-and-a-half-story framed and weatherboarded house faces west onto Solomons Island Road. Set on a brick foundation, it is an L-plan gable-roofed structure with its three-bay facade set into the front-facing gable end. The facade is composed of a side-lighted and transomed entrance and flanked to the north by two two-over-two double-hung sash windows. The hipped-roof screened-in front porch is supported on Doric columns. There is a gable-roofed dormer set into the north face of the roof and a one-story polygonal bay projecting from the north side of the house. The house is in very good condition.


