This two-story two-bay framed and weatherboarded structure is sited facing southwest onto Solomons Island Road as it curves to the east to become Charles Street. Set on brick piers, this building has a one-room form, an interior brick gable-end stove flue, and a gable roof. The windows are glazed with two-over-two double-hung sash. A two-story two-bay rear ell is as wide as the main section of the house is long. There is a one-story shed built onto the southeast gable end of the house and a one-story hipped-roof front porch. The structure appears to have been built at about the turn of the century as a dwelling. In recent years, it has served commercial purposes. It is presently vacant.


