This two-story framed and weatherboarded heavily altered structure faces northwest onto Charles Street near the junction with Patuxent Avenue. It appears to have begun as a turn-of-the-century two-story T-plan house, but it has been extended and altered several times. Various attempts to reorient the facade of this house on its irregular lot have resulted in oblique angles and an uncertain emphasis. The original weatherboarding has been replaced with asphalt paper. The house is not in good condition. It is currently divided into apartments.


