This one-and-a-half-story framed and weatherboarded bungalow faces south onto Charles Street between Maltby and Williams Streets. Set on a concrete foundation, it has a three-bay facade consisting of a central doorway flanked by wide windows. The gable roof has a ridgeline that runs parallel to the facade. It is interrupted by a big front-facing gable-roofed dormer. The front shed-roofed porch is screened in. There is a brick exterior chimney built onto the west gable-end wall. The roof is covered with standing-seam sheet metal. This house dates from the early twentieth century.


