This square-plan two-story framed and weatherboarded dwelling faces southeast onto Farren Avenue and the Chesapeake Bay. It is a three-bay double-pile structure with a central passage plan. The original sash are four over four, and in the windows of the mansard roof, they are two-over-two and double-hung. There is a two-story polygonal bay on the southwest side of the house, a one-story single-bay gable-roofed porch addition on the rear, and a shed-roofed one-story enclosed front porch. There are interior brick chimneys on the end walls. The original weatherboarding has been replaced with asbestos shingles. This house dates from the latter part of the nineteenth century.


