This two-story two-bay framed and weatherboarded four-square dwelling faces southeast onto Williams Street. It has a hipped roof with a ridgeline running perpendicular to the facade and a gable-roofed dormer set into each face of the roof. The windows are glazed with single-pane double-hung sash. There is a one-story hipped-roof front porch set onto Doric columns and a rear one-story hipped-roof shed addition. This structure dates from the early decades of the twentieth century. It now serves as office space for the Chesapeake Biological Laboratory.


