

CAPSULE SUMMARY CT-1156

The Michael and Evelyn Hall barn is located on Emmanuel Church road, approximately one mile from its intersection with Plum Point Road, in Calvert County Maryland. The barn is located on the west side of the road, and oriented on an east-west axis. The barn was recorded from the exterior, as owner permission was not obtained. It is located on a slight rise, and the ground slopes down to the south below the barn. The barn measures thirty-two by twenty feet and has a sixteen foot wide shed on the south side, and an approximate sixteen foot wide lean-to shed on the west. The small dimensions and cross-axial plan of the barn make it appear to date to the early nineteenth century. This impression is further confirmed by the extant riven clapboard siding on the north and east sides.

7. DESCRIPTION CT-1156

The Michael and Evelyn Hall barn is located on Emmanuel Church road, approximately one mile from its intersection with Plum Point Road in Calvert County Maryland. The barn is located on the west side of the road, and oriented on an east-west axis. There is no apparent association with any historic house or other barns. The barn was recorded from the exterior, as owner permission was not obtained. It is located on a slight rise and the ground slopes down to the south below the barn. The barn measures thirty-two by twenty feet and has a sixteen foot wide shed on the south side, and an approximately sixteen foot wide lean-to shed on the west.

The plan of the barn is cross-axial. There are two eight foot wide double doors centered along the north and south sides, and one four foot wide door on the east side. The north side has two four foot wide doors on either end that are raised approximately six feet above ground. It is possible these doors were used to load tobacco into the barn from a wagon that was backed up to it. Concrete blocks support the frame. The medium pitch roof is covered with metal, but was probably originally shingled. The barn has a combination of riven clapboard and vertical siding. Riven clapboards are extant across the north facade of the barn, and the east gable end.

The east gable has a definite separation line between the original barn, where the riven clapboards remain, and the south shed's east wall, where all the siding is modern and vertical. It is likely that this shed is an addition. It measures approximately sixteen feet wide and has a double door centered on its south facade. The south facade is sided with horizontal weatherboards on the lower half and vertical siding on the upper half.

The lean-to equipment shed to the west is almost certainly an addition. It is built of modern materials, and has a ten foot wide drive-through doorway adjacent to the barn itself. This shed is apparently a twentieth-century vehicle and equipment storage shed addition.

8. SIGNIFICANCE CT-1156

This barn is architecturally significant for several reasons. Its small dimensions and cross-axial plan make it appear to date to the early nineteenth century. This impression is further confirmed by the extant riven clapboard siding on the north and east sides. The doorways above ground on the north side are unusual, and have not been witnessed in any other recorded tobacco barn in Calvert County.

This barn also yields information regarding agricultural history in Southern Maryland. In February 1990, a tobacco barn survey was initiated in order to study the tobacco barns of Calvert County. Until fairly recently, tobacco was the most important farm crop of the county. More acreage was devoted to its cultivation than for both of the next most extensive farm products (corn and wheat). The barns and stripping houses related to this "Tobacco Culture" are widely recognized as the most common element on the rural landscape. These structures are also the most threatened, as the market for tobacco declines. They seem to have, at present, only limited capabilities for re-use. Many barns and stripping houses now stand empty. The purpose of this survey has been to gather information and document a wide sample of these structures before they disappear from the landscape.

The barn has remained relatively unchanged over the years, as much of the early horizontal siding remains. The south shed was added, probably at some point during the late nineteenth century, and the west shed is a twentieth century drive-through addition.

Combination of horizontal and vertical siding. Roof not extremely steep. Lean to equipment/vehicle shed to west built of newer materials. South shed has definite separation in roof line from body of old barn. Horizontal weatherboards (lower half) of south shed combined with vertical siding (upper half). Riven clapboard siding on east gable end, and north facade. Barn measures thirty-two by twenty feet. Has eight foot wide double door centered on north facade, and four foot wide door on east gable end. Two four foot wide doorways six feet above ground on either end of north facade. One eight foot wide double door leads into the south shed. The west shed has drive-through doorways ten feet wide adjacent to the corner of the barn.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This rectangular, frame tobacco barn is covered with a gable roof. The construction comprises a combination of posts and studs. Both horizontal and vertical board siding cover the barn. Several sheds have been added to expand the space in the barn.

They appear on the north and west sides. These sheds are sheathed in vertical boards, while the original barn is covered with horizontal weatherboards.

Large doors running the full height of the barn walls appear in the center of the south and east sides. Two large battened window-like openings also appear on the east side.

Modern metal sheeting covers the roof.




HORIZ. WEATHERBOARDS (Lower Portion)


