

CAPSULE SUMMARY (CT-1165):

Briscoe Barn 'D' is located on the west side of Mackall Road and is one of the many parcels owned by the Briscoe/Parran families in the St. Leonard/Broomes Island area. The barn is on the corner of Mackall at the entrance to a small farm. The barn's small size is rather unusual, although the construction materials and techniques are typical of barns constructed in the first half of the 20 th century.

7. DESCRIPTION (CT-1165):

Briscoe Barn 'D' is located on the west side of Mackall Road approximately one and a half miles from its intersection with Broomes Island Road. The barn is associated with a surrounding sharecropper's farm which includes an early 20th century farm house and two other tobacco barns (CT 1166, 1167).

Briscoe Barn 'D' is oriented on a north-south axis. The barn measures 20 x 24 feet with an aisle plan. The barn is of modern construction, employing circular sawn lumber and wire nails throughout.

The 24 foot width of Briscoe Barn 'D' is divided into two seven foot bays and a ten foot double door way, and the 20 foot length of the barn is divided into two ten foot bays. The barn is constructed on poured concrete piers which support a moderately heavy timber frame of posts and down braces. The tobacco hanging system is made up of peeled log tier poles. The vertical distance between the tier poles was not recorded.

8. SIGNIFICANCE (CT-1165):

Briscoe Barn 'D' is of modern construction and dates to the first half of the 20th century. The barn is associated with an early 20th century sharecropper's house on the Briscoe property. Its small size is somewhat unusual particularly in association with the two larger barns located nearby. Additional research may reveal an explanation for the construction of such a small barn.






