The 2 1/2-story, gable-front dwelling located at 9123 Atlantic Avenue is very typical of early North Beach bay-side architecture. Historic photographs indicate that the double front porch seen in this dwelling was a common feature of other houses along Bay and Atlantic Avenues, though few examples have survived to this day. The building has experienced very little alteration and retains most of its exterior and interior building fabric. It is however, in an advanced state of deterioration and is slated for demolition.

9123 Atlantic Avenue is located on a very narrow beach lot, immediately adjacent the boardwalk and overlooking Chesapeake Bay. This building is in an advanced state of deterioration and slated for demolition. Except, however, for the plywood used in the lower section of the porches, this building has undergone little alteration, and retains most of its original interior and exterior building fabric.

9123 Atlantic Avenue is a narrow, 2 1/2-story, gable-front, side-passage plan building. Its walls are sheathed in German siding, with asbestos shingles in the gables. Walls rest on a low concrete pier foundation. The roof has overhanging eaves with decoratively exposed rafter ends. The roofline remains unbroken and extends out to engage the two-story porch system. The 1st-story porch wraps around on the north side but remains engaged to the building. Fenestration consists of 2/2 windows. On the main facade, two windows are located on the right side of the 12-light front door, while on the second level a window is located on either side of a center 12-light door. Fenestration is irregularly spaced on the side walls.

This building is significant for its association with the architectural development of the early-20th century summer colony and resort community of North Beach, Maryland. Please refer to the continuation sheets for an historical sketch of the town.

9123 Atlantic Avenue's two-story, gable-front form is very typical of early North Beach architecture. According to historic photographs, the double front porch system seen in this building was very common along Bay and Atlantic Avenues, though few examples of this type survive. Another example of this once common form is seen at 8904 Bay Avenue. That structure is in excellent physical condition, but retains far less original material than 9123 Atlantic Avenue.

In 1919 this property was owned by W.J. Bailey whose improvements were assessed at \$350. This value is average for the block at that period. In that year assessments ranged from \$250 to \$500.

Section 8: History and Significance

North Beach is a fair to good example of an early 20th century summer resort colony and is a Maryland example of a national trend in community development initiated by the Industrial Revolution. Communities such as North Beach were a result of the growing middle class, mobility and consumerism resulting from the industrial economy that dominated the period. Dozens of beach resorts developed around the Chesapeake Bay in the years between the end of the Civil War and the Great Depression. Some, such as Gibson Island, catered to a rich, white, gentile clientele, while Highland Beach is an example of an African-American summer colony. North Beach was in the middle of the social spectrum. While deed restrictions excluded blacks, Jews were well represented in early North Beach. Excepting this major exclusion, by the standards of the day, North Beach was a heterogeneous middle-class summer community.

North Beach was platted in 1900 (revised in 1908) and incorporated in 1910. The town was developed by a group of principally Washington-based businessmen with ties to railroad, labor and banking. Conceived as a summer residential community and resort, the town was laid out according to a standard grid. In addition to houses, the town featured a variety of tourist and recreation-oriented businesses including theaters, restaurants, dance halls, bingo parlors, amusement arcades, and night clubs--including several gay clubs.

Most surviving historic buildings were constructed in the 1920s and 1930s, and include a good collection of early-20th century vernacular buildings. Represented building types include bungalows, shotguns, American Four Square and gable-front cottages. Most commercial buildings are either destroyed or extremely altered. Many of the town's historic structures were altered in the years immediately following World War II. In the post-war years North Beach completed a transformation begun in the 1930s, from a resort and summer colony to a permanent suburban community.


