This small 1 1/2-story structure, built in the first quarter of the 19th century, was originally a half-size version of the hall, parlor, and back rooms plan. An addition was made in the 1830's to enlarge the house and complete the plan. The present floor plan consists of four first-floor rooms and a short rear stair hall. There are two exterior chimneys on the early portion and one on the later addition. The paved piazza dates to the initial construction period and was extended along the addition when it was built.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house, of apparent 19th C. date judging from remaining construction material, was all but a complete ruin when renovated by the present owners. From the many 18th C. artifacts unearthed when the house was being worked on it apparently was built on the site of an earlier structure. There is no architectural evidence to support the 17th + 18th C. construction dates ascribed to the existing structure.

Like many such river front dwellings along the Patuxent it is a one storey frame building with a projection of the roof to form a porch along one wall. However, instead of the 3 "bay" end hall house usually seen, St. Jeromes is a 4 "bay" house with 2 doors occupying the middle "bays." Although not seen at the time of this survey, it is known that a window exists on a middle partition wall upstairs. This, and the two doors seem to support the theory that the house was built in two parts - the E end (present chimney end) 1st + the W. (river) end 2nd. There are two odd looking chimneys with long stepped "weatherings" on the E end. A single chimney at the W. end had collapsed and when the structure was renovated a floor to ceiling window was put in its place. The S. porch has 1 remaining original post of cedar wood with its corners chamfered, each chamfer terminating in a "lamb's tongue" at top and base.

HAS BEEN ALTERED. THE NE ROOM HAS ALL OF ITS FRAMING EXPOSED AND THE REAR STAIR IS OF A PROBABLE LATE 19TH C. DATE. THERE HAS ^{BEEN} SOME INTEREST EXPRESSED IN THE TYPE OF ROOF CONSTRUCTION USED AND A CLOSE EXAMINATION OF IT HAS BEEN PROPOSED BY CARY CARSON, SMCC.

St Jerome's Manor is similar to but smaller than Hawley's Manor.

Possible 18th c. date of west 1/2 of structure. Roof frame appears to employ a purlin (lq.) just above dormer window level.

ST. JEROME MANOR, an example of the Marine style, has elliptical arches on the porch and freestanding chimneys with pent. The house was built on 4250 acres surveyed in 1648 for Capt. Wm. Hawly; this property is called "manor" in the original records.

ST. RICHARD'S MANOR, or RICHARD'S MANOR, was built in the late Seventeenth Century on 1000 acres surveyed in 1640 for Richard Gardiner. Richard Keene owned the manor between 1653 and 1675. The house is much larger than it appears to be from the outside. [See plan.]



BARDS FIELD, or GRAY'S NECK, has pairs of chimneys close together at each end.

The Loker family tombstones nearby date from 1800. This family once owned "Mulberry Fields", the great mansion farther up the Potomac.
