Aside from Tudor Hall, the Spalding-Camaliier house is the earliest structure intended as an in-town residence still standing in Leonardtown, a county seat that until the third and fourth decades of this century boasted many such buildings.

Of distinctly late-Federal character, it is 2 1/2 stories in height and of brick construction. Exterior Federal-period treatment includes the painted wood lintels of the doors and windows and the bridged gable-end chimneys. There are several later additions.
