The Prospect Hill Farmhouse, constructed c. 1889-1890, is an imposing frame, two story, two room plan dwelling that once commanded expansive views of Breton Bay. Built by Mr. George Pabst, a wealthy New York merchant, the house represented a deviation from typical domestic architecture in St. Mary's County. Erected as a summer residence, the house featured a large interior chimney stack shared on the first floor by two rooms with a rear winder stair -- a floor plan more typically found in a New England farmhouse. Other interesting architectural features not typically found in the county are the series of small windows located near the eave line -- openings usually used for venting the attic story.

Judging from this architectural evidence, it appears as if Mr. Pabst appropriated different ideas about domestic architecture when he built the Prospect Hill Farmhouse -- ideas he may have taken from his native New York. Pabst's influence upon the property extended well beyond the architectural realm, however, for he also introduced progressive and alternative farming activities -- growing crops commercially such as turnips, cabbages, tomatoes, celery, as well as sweet potatoes as opposed to tobacco. He was also a founding member of the Leonardtown Farmers Club.

Today, the Prospect Hill Farmhouse as well as the surrounding property represent an extension of Mr. Pabst's progressive farming attempts and possibly his "northern" architectural sensibilities. While the house has been extensively renovated, enough evidence remains to raise important questions about the architectural motives of Mr. Pabst. Was he trying, for instance, to impose "northern" architectural and agricultural notions on a distinctively southern landscape? While questions such as this may go unresolved, the house and farm remain important for their association with the theme of improvement in the post-Civil War period and the role wealthy northern merchants played during this period.

The Prospect Hill Farmhouse is located approximately 0.5 miles southeast of the intersection of Knight Road and Bull Road near Leonardtown, Maryland. Situated on a rolling cultivated tract, the main dwelling is approached via a 0.1 mile long dirt farm road that extends south from Knight Road. On the east side of the drive is the Prospect Hill tenant house (SM-640) and to the west is the Prospect Hill tobacco house (SM-641). While the view is currently obscured by trees and overgrowth, the main dwelling once commanded an expansive view of Breton Bay. On the south side of the dwelling, a series of grassy terraces gracefully soften what is a rather steep slope down to Breton Bay.

The Prospect Hill Farmhouse, constructed c. 1890, is a two story, two room, single pile, frame dwelling with a one story ell. Erected on a common bond brick foundation, the dwelling's original sheathing was removed and replaced with asbestos shingles. The roof features an exposed cornice with the eaves supported at the corners with modest unfinished brackets. Pressed metal shingles cover the roof which is pierced by a large centrally located interior brick chimney. The ell, constructed in the mid-twentieth century, rests on a cinder block foundation and is sheathed with asbestos shingles. The roof is covered with pressed-metal shingles.

The primary or south elevation of the main dwelling is pierced by five bays on the first floor and four on the second. The first floor exhibits a centrally located two-pane-over-two panel door flanked on the west side by a two-pane-over-two-panel door and a one-over-one, double-hung, sash window and on the east side by two one-over-one windows each of which feature louvered shutters. The main door is partially sheltered by a shed roof awning, while a screened-in wrap around porch extends around the south side of the elevation. The second floor is pierced by three one-over-one windows and a paired set of slender one-over-one windows. Just above these bays are four, two pane, fixed sash windows which light the attic.

The west elevation consists of the main block's gable end and the rear ell's side. The main block is pierced on the first floor by a set of paired one-over-one windows and a single one-over-one window. This second window lights an original shallow shed roof projection which extends from the north side of the main block. This two story projection features a one-over-one window on its second floor. The rear ell features three, six-over-six windows and a two-pane-over-two-panel door. A centrally located, interior, brick chimney flue heats this one story addition.

The north elevation is composed of the ell's gable end and the main block's rear side. The ell projects northward from the center of the main block. The ell is pierced by a six-over-six window. The main block is distinguished by a projection topped by a cross gable. This projection is pierced on the second floor by a one-over-one window and on the attic story by a two pane fixed sash with a triangular crown. To the east of the projection is an original one story shed which is lit by a single one-over-one window.

The east elevation consists of the ell's side and main block's gable end. The ell is pierced by six-pane-over-three panel door, two six-over-six windows, and a two-pane-over-two panel door. The main block features a one-over-one window on the first and second floors, while a two pane fixed sash with a triangular crown lights the attic.

Judging from this architectural evidence, it appears as if Mr. Pabst appropriated different ideas about domestic architecture when he built the Prospect Hill Farmhouse -- ideas he may have taken from his native New York. Fortunately, articles in the St. Mary's Beacon shed some light on his background as well as his activities on the farm.

In April of 1886, Pabst purchased the 243 acre Prospect Hill Farm from J. Thomas Abell. In less than a month the Beacon reported that "workmen are busily engaged in building on the Prospect Hill Estate."¹ In June workers were busy making bricks for a kiln Pabst proposed to burn on his property.² The workers, however, were not yet erecting the main house, however, for in October, a Baltimore Sun article which appeared in the Beacon noted that "his temporary house, barn, and outbuilding are up but his mansion proper is to be commenced in spring."³ Delays must have hampered the project for it was not until June of 1889 that Pabst "ordered the lumber for a

7.1 Description

The interior of the Prospect Hill Farmhouse's interior is unconventional for the late-nineteenth century. The main block exhibits a hall-parlor plan that revolves around a centrally located stack. This traditional arrangement is uncommon for the timeperiod and region. Most, late-nineteenth century dwellings feature a center passage plan with the fireplaces located on the exterior ends. Another interesting feature is the rear projection which houses the winder stair. Ghosts indicate that the hall and parlor featured mantles, while other scars indicate the presence of shelving. A corner cupboard still survives in the west room. The door and window trim is relatively modest and undecorated. The second floor features a stair passage with a series of three bedrooms radiating from this central space. The most prominent feature in the partially excavated basement is a large stone base for the chimney. The ell consists of two rooms -- presumably the dining room and kitchen.

new and handsome dwelling to be erected on his Prospect Hill Estate."⁴ While these various articles help to affix a date on the house, they also relate how St. Mary's County became an important summer destination for wealthy merchants all along the eastern seaboard.

Indeed, in the aforementioned Baltimore Sun article, the reporter noted that two friends of Mr. Pabst, a Mr. George Borgfeldt and Mr. T.E. Studley "importers of fancy goods," planned on purchasing a site nearby. The article continued "It is thought other Northern men of means will follow the lead of these two wealthy gentlemen and purchase summer residences in St. Mary's County and handsomely improve them." The Sun as well as the St. Mary's Beacon had good reason to report the arrival of these elite businessmen. Almost as soon as Mr. Pabst arrived he set about improving not only the architectural appointments but also the agricultural arrangements -- regardless of the perceived cost. In 1886, for instance, he put large amounts of fertilizer down on his tenanted farm land -- free of charge to his sharecroppers, and he also cleared large amounts of acreage. He spent so much the paper reported that "already he has spent in improvements ten times the cost of the farm and he only seems to be well started in his operations."⁵ Pabst turned to crops not extensively grown in the county such as cabbage, turnip, tomato, celery, as well as sweet potato and urged others to turn away from tobacco as a staple crop.⁶ He also attempted to extend his influence by becoming an active founding member of the Leonardtown Farmers Club.⁷

Today, the Prospect Hill Farmhouse as well as the surrounding property represent an extension of Mr. Pabst's progressive farming attempts and his "northern" architectural sensibilities. While the house has been extensively renovated, enough evidence remains to raise important questions about the architectural motives of Mr. Pabst. Was he trying, for instance, to impose "northern" architectural and agricultural notions on a distinctively southern landscape? While questions such as this go unresolved, the house and farm remain important for their association with the theme of improvement in the post-Civil War period and the role northern merchants played in this historical theme.




Figure 1. Map of survey of the Knight Farm. The Prospect Hill Farmhouse is located at the southern terminus of the farm road.






Figure 2. Survey of Prospect Hill and Gillmuths Hills by surveyor John T. Wathen, August 12, 1837. Land Commission Record, Liber JH 3, Folio 378.
