The Morris/Gibson Store has been a landmark in the crossroads community of Avenue ever since it was built in the first decade of the twentieth century. In 1901 Andrew Jackson Morris purchased a two acre tract near the intersection of Colton's Point and Hatchet Thicket Roads. Taking advantage of the ideal location, Morris erected a two story, gable front, frame building to house his general merchandise enterprise. In addition to the building, Morris moved a one story building that was located at the present site of the Victory Bar (SM-656) and attached it to his new store. The combination of these two buildings made the store one of the largest in the area. In addition to the store Morris also built a dwelling (SM-662) for his large family as well as a movie house (SM-663). Together, these buildings provide a rare glimpse into the multi-faceted landscape of crossroads commerce in the early twentieth century.

In 1935, Andrew Jackson Morris died and day to day operation of the store briefly fell to his wife Grace Catherine Hill Morris. Between 1936 and 1957 the store was handled by a her children and their spouses which included Polly and Francis Gibson from 1936-1953 and Charles and "Bebe" Gibson from 1953-1957. In 1957 the store and accompanying house were sold. The store has since closed and the building has fallen into disrepair. The original store counter and shelving were removed and are currently located at the St. Clements Island Museum in Colton's Point. Scars on the floor and walls of the old store indicate where the shelving and counter originally were. Other interesting details on the building include the strongly built door on the north side and the bars over the windows on the main elevation. Like other stores in the seventh district, such as the Oakley Post Office and Store (SM-603) and the Bailey/Ellis/Millison Store (SM-657), security was a constant concern as its relatively isolated location made it a prime target for local thieves who could operate without concern for policing authorities.

Situated in the rural crossroads community of Avenue, Maryland is the Morris/Gibson Store. Built c. 1901 just west of the intersection of Hatchet Thicket and Colton's Point Roads, the store is oriented on an east/west axis and occupies a flat, one acre parcel. Visually and historically linked to the Morris/Gibson House (SM-662) and the Morris/Gibson Movie House (SM-663), the store retains much of its historical environment. The parcel is bounded to the east by Colton's Point Road, to the north by the Morris/Gibson House, to the west by a wood tract, and to the south by the old Avenue Sunoco station. The store remains linked to the aforementioned house via a concrete walkway that leads to the store's north door.

The Morris/Gibson Store is a two story, three bay commercial building with a gable front entry. The building's circular sawn, braced-frame rests on a series of brick piers that form the foundation. The horizontal clapboard is fastened to the frame with wire nails. At the juncture of the wall and roof is a boxed cornice. Sheathed with corrugated metal, the gable roof features a single brick chimney flue that protrudes from the middle of the building. In the 1980s a cinder block wing was added to the south side of the store replacing an earlier wing.

The front or east elevation consists of the store's gable front. On the first floor, the fenestrations is composed of a centrally located panelled door flanked on either side by six-over-six, double-hung sash windows that exhibit vertical metal bars. All of these bays are shaded by a porch that is supported by a series of four, large, square columns (one has since fallen away). Cornice returns frame a centrally located, second floor, six-over-six window. The south side of the east elevation is dominated by the c. 1980s cinder block addition. This addition replaced an earlier one story frame building that was moved to this location and attached to the store. According to oral tradition, the building occupied the present site of Long's Boat Shop/Victory Bar (SM-656). This masonry addition is pierced by a single door.

The north elevation's fenestration consists of a six-over-six window and a four panel door. Similar to the door found at Richard Carroll Ellis' Grist Mill in Bushwood (SM-609), the entry is heavily constructed with each of the four panels exhibiting diagonal battens.

The west elevation consists of the main block's rear gable end and the side of the 1980s addition. The main block is pierced by a six-over-six window on both the first and second floors. The addition does not feature any openings.

The south elevation is composed of the addition's gable end. It consists of a large metal garage door that is also glazed.

While the interior was not accessible at the time of the visit, the original interior could be seen through the window. From this vantage point, scars on the walls and floor reveal where the original shelving and countertop were located. Both the shelving and countertop were removed and installed into a permanent exhibit at the St. Clements Island Museum at Colton's Point.








ROAD CLASSIFICATION
