1789

Trent Hall Neck was granted to Major Thomas Truman, member of the Maryland Council, in 1658. The present house was built in 1789 by John DeButts; it has been rebuilt in recent years.

Trent Hall was owned by the Truman, Greenfield, Briscoe and Thomas families for many generations. A private cemetery with tombstones dating from 1672 remains here.
