This one-story, brick-nogged frame house has a Flemish bond brick gable on the north end with tall double exterior chimneys. It has an exceptionally steep common rafter roof with heavy, flat false plates. A piazza on the east facade probably dates from the initial construction. The side passage, double parlor floor plan is not well developed here. Original mantels, chair rail and stairs remain in the main section. The early kitchen wing was rebuilt in the 20th century.

To the northwest of the kitchen stands a rectangular frame outbuilding, possibly a meat house or dairy.

Massum Eyrie is significant as an example of a late eighteenth/early nineteenth century frame St. Mary's County dwelling with a side hall, double-pile plan. During a recent renovation, many of the original features of the house were removed including exterior siding, windows, interior flooring, and decorative features such as mantles, moldings, and the stair. Much of the original material that was removed or replaced is currently stored in two of the barns on the property. Notably, the exterior form of the house has been preserved. The roof was also re-sheathed with wood shingles in an effort to preserve the historic character of the house. Unlike the house itself, the setting of Massum Eyrie is largely unaltered.

George W. Pembroke, Sr., died possessed of Massum Eyrie in 1860. It is unclear how he came to own the property as there are no deeds to either him or his wife listed in the St. Mary's County Courthouse. It may be that the deed to Pembroke burned in the courthouse fire of 1832 or that George or Ann Pembroke inherited the tract.

George W. Pembroke, Sr., died intestate and his real estate was sold at public auction. An advertisement for the property in the St. Mary's Beacon dated January 26, 1871 describes it as "...beautifully located on the Chesapeake Bay running back to the Three-Notched Road. The cleared land is all well enclosed, clean, and well-drained and its condition is equal to most of our best lands. There is abundance of wood and timber. The buildings are all substantial and in good condition." "Massum Eyrie," also known as "Masson Aire," remained in the Pembroke heirs family until the 1930s.

Massum Eyrie is located at the end of an unpaved road that extends from Old Route 235 to the Chesapeake Bay near Lexington Park in St. Mary's County, Maryland. In addition to the dwelling, a series of outbuildings are located on the property. The house faces east with the principal gable oriented on a north/south axis.

Probably built in the early nineteenth century, Massum Eyrie is a one-and-a-half story, frame structure with a side hall, double-pile plan measuring 26 feet by 32 feet. The house is supported by a continuous brick foundation. It is sheathed with german vinyl siding and is roofed with wood shingles. A one-story kitchen wing extends to the north of the main block. According to the current owners, the wing was added around the turn of the century. This wing is sheathed with vinyl siding and is roofed with wood shingles.

The east (main) elevation is pierced by a modern door and two six-over-six sash windows with paneled shutters. (During a recent renovation, all of the original windows were replaced.) The shed-roof porch that extends across the full width of this elevation is supported by square wood posts. The original wood floor has been replaced by poured cement. Two gable-roof dormers lighted by six-over-six sash windows pierce the upper half story of the house. The kitchen wing extends to the north and is pierced by a modern door flanked on either side by a six-over-six sash window with paneled shutters.

The north elevation of the main block is pierced by two eight-over-eight sash windows on the first floor. The second floor is pierced by two six-over-six sash windows and the eave by one six-over-six sash window. Two exterior, Flemish-bond brick chimneys stand against this brick gable end. The chimneys are finished with decorative, gothic-arched chimney caps. The flush gable end of the one-story kitchen wing is pierced by two small six-over-six sash windows. Two small one-over-one sash windows light the eave. A modern, exterior brick chimney stands against this gable end.

The west elevation of the kitchen wing is pierced by a modern door flanked on either side by one six-over-six sash window with paneled shutters. The main block is pierced by two six-over-six sash windows with paneled shutters and a modern entrance door on the first floor. The upper half story is pierced by two gable-roof dormers lighted with six-over-six sash windows.

The south elevation is pierced by a modern door on the first floor that replaced an original window in that location. The second floor is pierced by two six-over-six

sash windows with paneled shutters that flank a modern octagonal window. The eave is pierced by one six-over-six sash window with paneled shutters.

The interior of the main block has been significantly reworked. Within the course of a recent renovation, the wood floor was removed and the area under the house was infilled with reinforced steel and concrete. The concrete was then sheathed with modern wood flooring. During the course of this renovation, the pit-sawn floor joists were removed and placed in storage in one of the barns on the property. The original parlor mantels were removed and are in storage in the barns as well. The finest of these Federal style mantles consists of recessed paneled pilasters surmounted by a tripartite frieze. The frieze is decorated with bands of reeding and is finished with a heavily molded cornice. Cut nails with double struck heads are imbedded in the mantle backboard. The partition wall between the east and west parlors, originally pierced by a single door, is now pierced by a double door. The hall is floored with tile and the original winder stair was removed and rebuilt. The baluster now consists of a wrought iron railing. A portion of the original bolection molding that decorated the stairwell remains in place.

The second floor consists of three bedrooms and a bath. Some of the walls on this floor were replaced. Cut nails with double struck heads were found in the left-over timbers from these walls. The original flooring is intact here beneath a layer of plywood and carpeting. The second floor baseboard is a plain board finished with a narrow bead. A small enclosed stair provides access to the attic. A vertical panel door opens to a closet underneath the stair. The closet is plastered and remnants of old wallpaper are located here. The stairs consist of reciprocal sawn lumber and the heads of machine cut nails are visible. The stair balusters are plain, rectangular posts. The attic space is divided into two rooms.

The interior of the one-story kitchen wing consists of one large room with a tiled floor. It has been finished with new cabinetry. According to the current owners, the original kitchen rafters are spliced at the apex and pegged together. The kitchen loft is now the location of the heating unit for the house.

The two outbuildings located closest to the house are the brick milkhouse and the frame smokehouse. The milkhouse, now used as the pump house, is a square, common-bond brick structure capped by a pyramidal roof with wood shingles. A vertical panel door is located on the east side of the building. Two window openings, six-over-six sash windows that are now boarded over, pierce the walls of the milkhouse. Both the door and window openings are surmounted by brick arches.

The meathouse is a frame structure sheathed with weatherboards attached with wire nails. Like the main house, the roof is oriented on a north/south axis and is

covered with wood shingles. The meathouse has flush gable ends and the roofline is finished with a boxed cornice. A board and batten door hung on metal strap hinges pierces the south elevation of the meathouse. The interior floor is brick and retains a central hole to hold a pot of coals for use in the smoking process. The interior walls are sheathed with diagonal boards.

North of the milkhouse and smokehouse stand a tobacco barn, chicken coop, and guest cottage. The cottage dates to the early twentieth century and is ell-shaped with an infill in the northwest corner. It faces south with the roof oriented on an east/west axis. The small building is supported by a cinderblock foundation and is sheathed with weatherboard siding. The roof is covered with corrugated metal. The south elevation is pierced by a central, five-panel door flanked by a six-over-six sash window with wide surrounds on either side. The door is sheltered by a gable-roof portico supported by wood posts. The west elevation of the main block is a flush gable end pierced by a six-over-six sash window with wide surrounds. A flat-roof addition extends to the north of the main block and is pierced by a six-over-six sash window with wide surrounds and one small single-light window. The north elevation of the flat roof addition is pierced by one six-over-six sash window with wide surrounds. An attached gable-end wing is pierced by a six-over-six sash window with wide surrounds and a vertical panel door that provides access to the loft space above. This wing is pierced by an interior brick chimney. A blind shed-roof addition extends to the east of the wing. The east elevation of the shed is pierced by a four-light-over-three-panel door flanked on either side by a six-over-six sash window. The east elevation of the main block is a flush gable end pierced by one nine-over-six sash window with wide surrounds.

The chicken coop is a small one-story, shed-roof structure sheathed with weatherboards and roofed with corrugated metal. The tobacco barn is sheathed with circular sawn vertical board siding and is roofed with corrugated metal. It measures 52 feet in length by 20 feet in width with a 16 foot shed on the south side. The hewn sills are supported by brick piers. They are attached with mortise and tenon joints secured with wooden pegs. Hewn down braces add stability to the frame and are attached to the sills with machine cut nails. Both the tie beams and top plates are hewn. The rafters are skinned logs with feet that rest on a flat false plate. The horizontal tier pole supports are skinned logs that have been nailed to the studs and down braces with machine cut nails. The shed is on the same bay system as the main block of the barn.

West of these structures stands a large breeder house for chickens, a gambrel roof tobacco barn, a dairy barn, and an implement shed.



Following Ann Pembroke's death, the tract passed to four of her children including Laura Dunbar, Rosa Pembroke, Charles Pembroke and Alice Ford. Charles A. Pembroke purchased the interest of all the heirs, but eventually lost the property in a mortgage foreclosure in 1895. William and Alice Ford then purchased the property which had come to be known both as “Massum Eyrie” and as “Masson Aire.” It remained in the Ford family until the 1930s.

IT IS OF THE VERY TYPICAL ONE STORY FRAME TYPE WITH AN END HALL PLAN, A PAIR OF EXTERIOR END CHIMNEYS (W. END) AND A PORCH FORMED BY THE EXTENSION OF THE ROOF (N. FACADE). WHAT IS INTERESTING AND PERHAPS SIGNIFICANT ABOUT THIS HOUSE IS THAT IT APPEARS THAT MOST OF THE INTERIOR AND EXTERIOR FABRIC REMAINS INTACT.

EXTERIOR DETAILS INCLUDE THE TWO CHIMNEYS WHICH DIFFER SLIGHTLY IN DESIGN BUT APPEAR TO BE OF THE SAME DATE, THE W. END WALL OF BRICK, NARROW WINDOWS OF 9/9 PANE SASH AT THE FACADE, AND A LATER KITCHEN ADDITION TO W. (CHIMNEY) END.


