Patuxent River Naval Air Station Chapel

7.0

The Patuxent River Naval Air Station Chapel is located on a level rise at approximately 60-foot elevation, facing and less than 300 feet north of Cedar Point Road. The Chapel, built in 1916, is the last of a series of at least three churches established in the area (the two previous dating to the late 17th century -- the site of which remains unknown, and the second in 1795 -- see 18 Sm ³⁹⁸ 362), having been converted to a chapel upon the establishment of the Naval Air Station in 1942. The Chapel is a 1½-story molded concrete block structure with a gabled, slate-covered roof, small entranceway, and tower with crenelation.

The NAS Chapel, built in 1916, is a rather typical church building of the period.
