DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This structure is of interest in that it is one of 2 remaining vict. stores bldg. in St. Mary's and the only one remaining physically intact (from the ext.).

It is 2 stories in height with a cent. iron girder framing a vict. style venetian window. at the 1st level are 3 "bays": a double door flanked by large multi paned sash windows with full width lowered shutters. The 1st level of the S. ele. (front) has narrow vict. clephds. tongue + groove, and secured in a diagonal position resembling a herringbone pattern. There is a vict. porch at this ele., ~~and~~ additions of (1 story) at the W. end and (2 story) at the N. rear wall.


